Mayor Miller announced that we are going to codify some policies related to our non-union employees and there are three resolutions. The policies will mirror our union contract.

VACATION TIME: NON-UNION FULL-TIME EMPLOYEES

RESOLVE that Vacation Time for all Non-Union Full-Time Employees of the Inc Village of Russell Gardens is earned after 1 year of Employee's start date (anniversary date) and must be used within 364 days of the Anniversary Date. Unused vacation time earned (not to exceed 3 days, subject to the Mayor's approval) may be carried over to the following year and must be used within 5 months. Vacation allowances shall be allowed as follows:

Two weeks after 1 year.

Two weeks and one day after two years.

Two weeks and two days after three years.

Two weeks and three days after four years.

Two weeks and four days after five years.

Three weeks after six years.

Three weeks and one day after seven years.

Three weeks and two days after eight years.

Three weeks and three days after nine years.

Three weeks and four days after ten years.

Four weeks after eleven years.

This resolution is not intended to create a contractual right and the Village reserves its rights to amend this resolution and amend the Village's vacation policies at any time.

HEALTH INSURANCE: NON-UNION FULL-TIME EMPLOYEES

RESOLVE that all Non-Union Full-Time Employees of the Inc. Village of Russell Gardens covered under NYSHIP will be responsible for 25% of the cost of Health Insurance provided by the Village if the annual premium exceeds \$22,000 for Family Coverage or \$12,600 for Individual coverage during any fiscal or calendar year; The Employee will be responsible for 25% of the increase cost only to the extent that the health insurance cost exceeds the \$22,000 for family or \$12,600 for individual coverage per year.

This resolution is not intended to create a contractual right and the Village reserves its rights to amend this resolution and change its contribution rates at any time with or without notice. However, at no time will the Village's contribution rate be less than the contribution rate required by Civil Service Law §167(2).

RETIREE HEALTH INSURANCE

RESOLVE that former Full Time Employees of the Inc. Village of Russell Gardens covered in retirement under NYSHIP shall be responsible for 25% of the cost for Retiree Health Insurance paid for by the Village if it exceeds \$13,215 for Family Coverage or \$4,665.00 for Individual coverage during any fiscal or calendar year, the Retiree will be responsible for 25% of the increase cost only to the extent that the health insurance cost exceeds the \$13,215. for family or \$4,665.00 for individual coverage per year.

This resolution is not intended to create a contractual right and the Village reserves its rights to amend this resolution and change its contribution rates at any time with or without notice. However, at no time will the Village's contribution rate be less than the contribution rate required by Civil Service Law §167(2).
